Generous support from members, foundations, and Chicago's top civic, corporate, and philanthropic leaders this year made it possible for The Chicago Council on Global Affairs to organize and host more than 200 public and leadership programs and to influence important policy debates through studies, public opinion surveys, conferences, and task forces. In 2013-14, individuals provided more than \$4.6 million in support, corporations more than \$2.9 million, and foundations more than \$2.6 million, a total increase of more than \$1 million over fiscal year 2013. This expanding base of support ensures the Council remains financially stable while also enabling it to enhance its programming and studies offerings and reach new audiences.
